# 2017 Inbounds Left September 5<sup>th</sup>

IL IFYE Association sponsored Poppy Lewis, from Wales, and Matthias Steiner, from Austria. They arrived in Illinois on June 19<sup>th</sup>, spending their first seven days at Sue Herren's house. The day after their arrival was Matthias's birthday. Poppy and Sue sang 'Happy Birthday' at breakfast with a candle in his roll. They were troupers, participating in morning water aerobics in the neighborhood pool. The ladies enjoyed meeting them and are still asking about their wellbeing. They toured the St. Louis Zoo where they got to pet the manta rays. They had lunch on the hill at Forest Park and viewed the Monet at the St. Louis Art Museum. They rode to the top of the Arch, toured Anheuser-Busch, and visited Ball Park Village. Their last evening, they went to an outdoor concert at Eckert's and met up with Dale and Crystal Yonker.

At the crack of dawn on June 25<sup>th</sup>, Matthias caught Amtrak to Chicago and then a train out to Elgin to

spend his first three weeks at the home of Beth and Bob **Gehrke**'s home, in Elgin, IL where they farm about 2000 acres of corn, soybeans, wheat and hay. He arrived during hay baling season. On August 13<sup>th</sup>, Matthias went to Monee, IL to spend his final three with Vivian and Jay **Mather** (and their daughter and two sons) who live on a "hobby" farm of five acres with cows, chickens and dogs.

Poppy was driven to Springfield on June 25<sup>th</sup> to meet her first family and spend the afternoon at the Lincoln museum. She spent her first four weeks with Kara and Jamie **McClintock** (and their three daughters) to experience life in the rural town of Washington, IL. The McClintock's had recently returned from living in China for five year. On July 23<sup>rd</sup>, Poppy headed to the dairy farm of Annie and Ken

**Schwoerer** (and their four daughters and a son) in Bloomington, IL for four weeks. The farm also has about 120 egg laying chickens and 320 acres of grain. On August 20<sup>th</sup>, Poppy head up to the **Goebbert**'s farm for two weeks.

# **Poppy Lewis-IFYE From Wales**

I want to thank Illinois IFYE association for enabling me to undergo my trip to the states this summer to spend time with a variety of host families within the Illinois area.

I came to Illinois without any expectations of what I thought the trip would consist of and what I would be doing when I got here. I very much enjoyed my trip in its entirety and felt that my 3 host families had great differences meaning I could have three completely unique experiences during my time here. I went from living with a family of three young children and a mum and dad in a nice little town, to an old-style family farm out in the country, and then to an agri tourist business out in the suburbs of Barrington with a quick train journey to the city.

Throughout my stay, I can honestly say I couldn't have asked for 3 any nicer and kinder families, who were always willing to help to make me feel welcome and happy, and fulfill anything that I wanted to do while I was here. I was able to learn new things about the country and about myself at every place that I went to and for that I was truly grateful.

I managed to have a great experience on the 4th of July with a fun day at the parade and shown a true family celebration, with fireworks in the night time! Each family made sure that I tried all the different foods that would appear to be in America and not in the UK - E.G, smores, tator tots, biscuits and gravy, and the list goes on. I experienced a true American family farm and learned all about the different crops that are grown here, as well as having the opportunity to visit other dairy farms near the area that were doing things slightly differently. I saw firsthand the great effort that goes into growing, keeping and selling vegetables here in the states and how it compares to the way we do it at home. And of course, seeing an agri tourist business in motion gave me a great opportunity to compare it to what I have within my family business and bring ideas home with me.

While I thoroughly enjoyed living with the families in their everyday life and doing what they do, it was great to be able to go on day trips, whether this would be to visit the local town, go to the county fair or visit the big city. Overall it is impossible to summarize my trip in such a small amount of words as I did get to do so much that developed me as a person and that I will never forget. But I can definitely say it was an amazing 3 months that I wouldn't change and I am very grateful for everyone who helped to make the experience so special.

### The home stay experience, By Sue Herren

The home stay experience, as we all know, is unique and the underpinning hallmark of "peace through understanding". This past August I had the great fortune to return to Japan and stay with both of my "host" families, instead of being a tourist. Forty-two years ago, I was in the first delegation from Illinois to Japan staying with my first host family (LABO). Thirty-nine years ago, I started a 'Year in Japan' program with a second host family. Host dad #2, had a stroke a year ago, so it became increasingly important to me to spend some quality time with all four of my host parents.

I was anxious about returning because I wanted to stay in their homes this time, not a hotel, but understood the great favor I was asking, especially as they are all in their 80s. The first couple days after I arrived were really tough. The language barrier... Fitting into their daily routine; making meals, laundry, cleaning house, daily grocery shopping... Eating all the food my host mom prepared and put in front of me... Then there was the eventual boredom that comes from a change in routine and not knowing what to do in with "down time" in someone else's home.... and, the eventual need for some alone time.

As I was moving through all these experiences (again as an adult), I pondered how this experience could help me improve my commitment to the current inbound/outbound IFYE program. I feel better equipped to discuss the eventual ebb and flow of being a host family. I re-experienced cultural differences. For example: Before I left, I stressed over what clothes to pack. I wanted to make sure I took "appropriate" attire. I laugh, the look on my mother's face (#2), when she first saw me let me know I had failed! It became a daily joke, as I tweaked the wardrobe and sought approval - before I left the house so as to not be an embarrassment. Women my age don't wear shorts. They don't wear sleeveless tops. Even if it is 98 degrees and 98% humidity. (smile).

I am blessed to have had my first IFYE experience. It sent me on a path unknown.... It has brought me joy and understanding throughout my whole life. This trip, I saw four parents, one sister, two brothers, two sisters-in-law three nieces and one nephew. I navigated the trains alone and rekindled a desire to study the language. I have an invitation back for the 2020 Olympics, but would love to return next year. I have promises to have the nieces and nephew sent to me over the next five years. Once again, I was able to have the "home stay" experience, with both my families and I am recommitted to a "knowing" of why IFYE promotes the "home stay" program.



### Ways to Donate to IL IFYE Assoc. (tax-exempt) Fund.

Meg Cline, Vice President for Gift Planning and Trust Services, University of Illinois Foundation presented "Ideas for Maximizing Your Charitable Gifts" at the IL IFYE Spring meeting March 4, 2017. She shared various ways of charitable giving for our membership to support our tax-exempt fund.

#### Meg shared four ways to give:

**Bequests** (gifts received through a will, trust, or beneficiary designation) are vital for the continued financial support of IFYE. She explained there are few gift requirements for a bequest. If you wish to make a bequest, the language should read as follows to ensure the gift is administered appropriately: "I give, leave, bequeath (e.g. % of estate, specific dollar amount, residual value) to the University of Illinois Foundation, a not-for-profit corporation located in Urbana, Illinois, to be contributed to the Illinois IFYE Association Fund".

**Beneficiary designation,** or a paid on death (POD)/Transfer on Death (TOD) designation. Bank Accounts, IRA's, savings bonds, life insurance, donor advised funds, brokerage accounts, and mutual funds all have the ability to assign a beneficiary designation. If you would wish to assign some funds to our fund as a beneficiary the following language is needed:

University of Illinois Foundation, Tax ID 37-6006007, 1305 W. Greet Street #214, Urbana, IL 61801 FBO: Illinois IFYE Association Fund.

**Charitable Gift Annuities** (CGAs). This can be a great tool to increase income on low yielding investments (CDs, short-term bonds, etc.) where you do not need to invade principal and you wish to leave assets to fulfill charitable obligations. The minimum age is 60 and the minimum contribution is \$10,000. Interest is paid as a quarterly annuity for the lifetime of the donor and up to one additional beneficiary. Upon the income beneficiaries' death, the remaining proceeds pass to the University of Illinois Foundation to benefit IFYE.

**Charitable IRA Rollover**, after you have attained the age of 70 ½, the tax law permits you to make a direct transfer up to \$100,000 annually to a qualified charity. The direct transfer has two main benefits: 1) Any funds transferred to a charity will count towards or cover your required minimum distribution (RMD) for that tax year: and 2) Distributions will not be added to your taxable income. You will not

receive a charitable deduction, but being excluded from income is more advantageous than a deduction. The funds must come directly from the IRA accounts with the check written to: the University of Illinois Foundation FBO Illinois IFYE Association Fund.
