You will be hearing more from and about these 2016 Representatives in the coming months. The Board's intention is to have another group of IFYEs leave in September 2016.

FINANCIAL POSITION of the IFYE ASSOCIATION UPDATE:

Thank you for your continued and much needed financial support! Financial donations are doing well!

Current position: Over \$140,000 has been donated toward our \$331,000 budget for 2016. This is wonderful. 1968 IFYE alumni have made a group pledge of \$25,150 to match donations made by other alumni before October 1, 2016. They will donate \$1.00 for each \$6.00 you give. That means for every dollar you donate, almost 17% will be added! Where else can you get that return? If the match is completed, the budget for 2016 will be achieved. Thanks to all those that have already made \$39,540 donations toward this match.

How to Donate: Here are some ideas that may help you support IFYE:

- 1. Support an IFYE: Orientation will be conducted in Washington, DC this month. The cost for inbound and outbound IFYEs is \$750 each. You can sponsor a participant by indicating that you wish your funds to go for this activity.
- 2. Are you over the age of 70? If so, and you have an IRA or retirement plan such as a 401(k), you need to take a Minimum Required Distribution (MRD) each year.
- Are you aware that Congress allows any MRD withdrawal made directly to a charity to be TAX-FREE? This means you can donate to IFYE and that money would not be taxed. The donation must come directly from your IRA or retirement account to IFYE. It cannot be placed into your personal accounts and then donated to IFYE and qualify for no-tax treatment. Contact me if you have

questions or need procedure information. Please also consult your tax advisor for further information.

- If you have already donated to IFYE, but did not use the process I just mentioned for your IRA, but you would like to do so, please contact me. There is a way that this can be accomplished. There are steps that must be completed and it is something that should be done on an individual basis. This process has been done by a few IFYEs in the past, so it is a workable plan. Contact me adeisher@bex.net and we can discuss it further.
 - 3. Small donations on a regular basis are appreciated. The "big checks" are nice and very helpful, but a small regular donation is equally important. And you do not need to give your bank information to anyone or have computer involvement!

Yes, if you want to make a monthly donation of \$10 or more, that can be done at the htt ifyeusa.org/donate.

Several IFYEs are making monthly or quarterly donations from their checking accounts by instructing the bank or holder of the funds to send a check! In a couple of cases, the check does not even show the name of the donor. That is confidential and the gift at that point is anonymous. The Treasurer or myself go to the source of the check, provide our credentials, and then we can obtain who the donor is and give proper credit.

Why donate?

At this time we are more dependent than we like on the IFYE alumni for financial survival. Efforts are being made to change this situation. We are positioning the IFYE program so businesses and industry will provide funding in the future. But we are not to that position yet ... maybe next year. There are a lot of options that are "in the works" but progress is slow. One point is certain; we cannot expand the IFYE program and expect the IFYE alumni to financially carry the financial requirements of that expansion. Please contact me if you want to know specifics of what is being done in this area.
