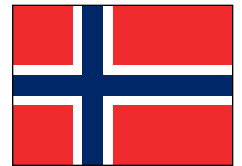

IFYE is a Registered Trademark

More than 12 months ago, the IFYE Association Board of Directors began the arduous process of trademarking the word "IFYE," a Standard Character Mark according to the US Patent and Trademark Office (USPTO).

You may remember information over the past year where we engaged an attorney with the intent of trademarking International Farm Youth Exchange™. Our attorney searched the records of the Trademark offices to ensure that

our logo and the word "IFYE" were both protected; he also researched to determine the status of the term "International Farm Youth Exchange." He discovered that the logo was protected by the registered trademark in November 2007. However, the word "IFYE" itself was not a registered trademark. The Board authorized the attorney to file a request for a registered trademark for both "IFYE" and "International Farm Youth Exchange."

Common Law Trademark Rights

On December 14, 2022, we received notice from the USPTO that our request to register International Farm Youth Exchange was denied. We have the right, and were advised, to continue the use of the ™ at the end of the word Exchange. This mark indicates to all that the words are being used as a trademark and "the owner is claiming common law trademark rights." But it is not registered. That helps to protect us from another entity trying to use and register the term. IFYE will continue to use the ™ with International Farm Youth Exchange on our website and written information, letterhead and brochures, etc. As an IFYE, if you have occasion to use International Farm Youth Exchange in citing our beginnings, you should use the ™.

Approval of "IFYE" as a Trademark

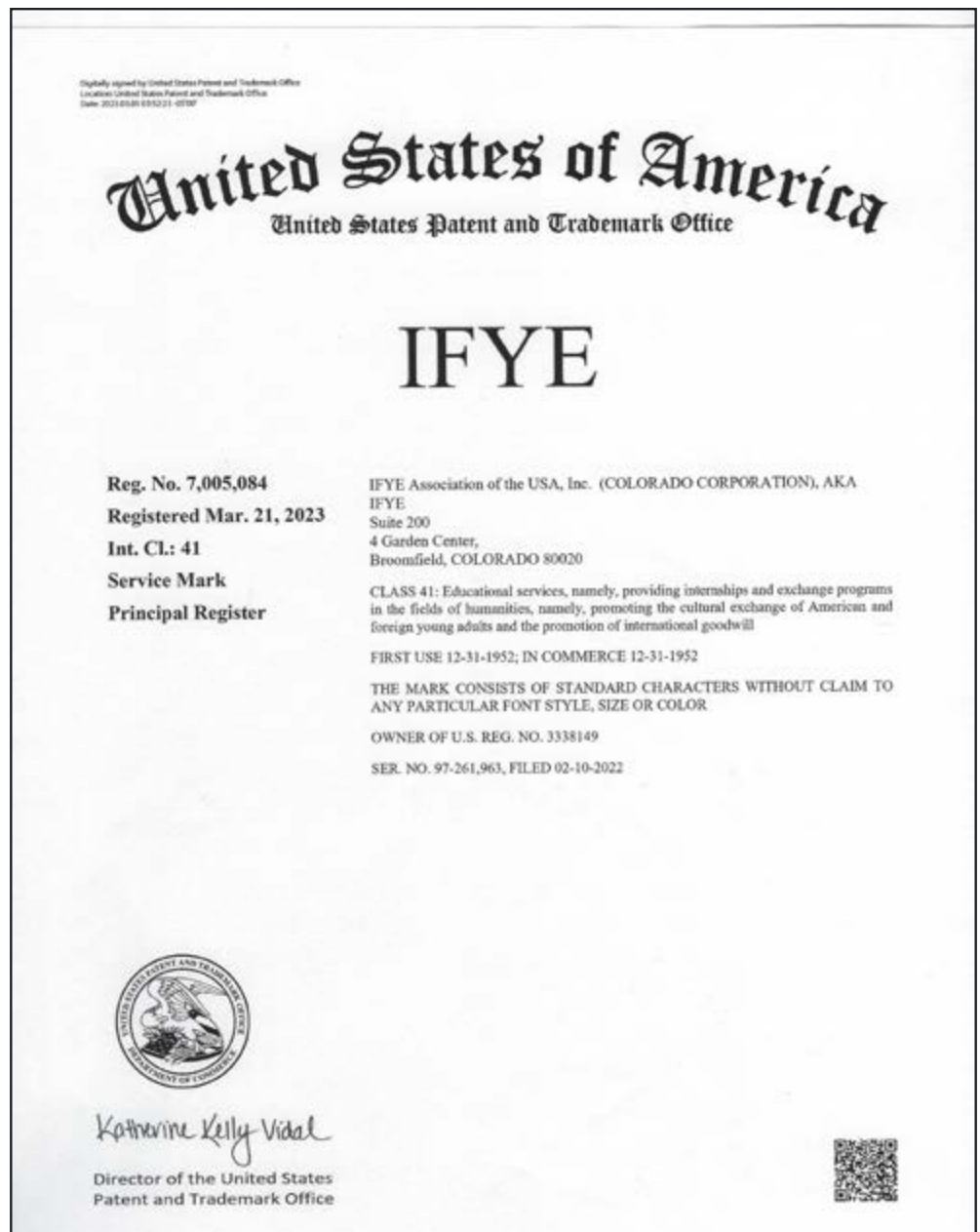
On March 21, 2023, IFYE was notified by the USPTO that our application to register the word "IFYE" as a trademark was approved. This was an important action for IFYE to take. It protects the word "IFYE" from being used in interstate commerce by any person

or organization other than The IFYE Association of the USA, Inc. or those organizations that IFYE grants permission to use by a Memorandum of Agreement. We believe there may be some use of our acronym by others and the Board will address that issue in the coming months.

Domestic vs International Protection of Trademark

This protection of our trademark by the USPTO does not extend to the international arena. So, all our IFYE peers in other countries still have the right to use the word and the logo. In the near future, the Board and staff will revise our written materials to include the registration mark. When we have the guidelines ready for use, they will be published within our portals with instructions for appropriate use.

Please note the addition of our registered trademark on our website header and footer, as well as on this IFYE NEWS. You will be seeing more use of it as we move ahead since the approval of our use.





Why IFYE's 75th Year is Important to Me

Indulge me to share a personal story of why IFYE is important to me during this 75th year of IFYE's existence.

In late March, my husband Gordon and I departed on a 10-day Caribbean cruise. He boarded with what he thought was a backache. Fast forward to the sixth day of the cruise and it became very apparent he needed to

go to the hospital – in Costa Rica, a country new to us and neither of us spoke Spanish. Before I go any further, just know that we were well taken care of, we are home, and Gordon is recuperating.

The IFYE Aspect

As IFYEs, we quickly learned how to assess a situation, make a quick decision, and when needed, ask for help – and if we didn't know the language, we often asked with a smile.

While traveling in the ambulance three hours to San Jose, I kept asking myself who do I know in Costa Rica? The better question was who did I know who knows Costa Rica? My fellow Ohio IFYE/YDP (to Nicaragua), Mary Ann Vaughan Tinus, quickly came to mind. She shared the information with IFYE/YDP Grace Woodman-Fernandes (MI to Costa Rica). All of a sudden, we were no longer alone in Central America. As luck would have it, we didn't need to call on Grace for help, but knowing she was nearby was comforting.

Is IFYE still relevant?

Over the past 75 years, we've reached out, leaned on, helped out, and worked with our IFYE brothers and sisters and families around the globe. Since joining the IFYE Board in 2019, I've often asked myself what would happen if we were no longer able to send out IFYEs nor receive them. In this age of instant communication, do we really need IFYE? Is it as relevant for today's young adults and world as it was 51 years ago when I left for the Philippines? The answer is *absolutely*. IFYE is needed more today than it was when our founders from Cornell University had this great idea of Peace Through Understanding by living with host families.

Financial Support and Your Stories

Clearly, we need funds to continue to tell our story and send out IFYEs. Our membership has been and continues to be generous with financial support to IFYE; we cannot operate without it and your Board of Directors is grateful. I know most of you agree that IFYE has been an integral part of our lives. The lessons learned are too many to list here. Unfortunately, many of our country's elected leaders in Washington, D.C. do not know what we do or why we are important. That's why sending emails to your US Representatives, Senators, and those on the Ag Committees for the 2023 Farm Bill is so critical. They need to see our worth and hear our stories and they need to hear from each of us frequently. (See page 8 for information on writing your Senators and Representatives. Ed.)

Our Grant Writer, Mary Springer, and I have been contacting the businesses and following leads we garnered from the 2023 Commodity Classic, other exhibits, and from leads that many of you have given us. We are telling the "IFYE story" and showing why IFYE is important to agriculture and agribusiness. It takes time to develop those relationships and we still need more contributions of stories.

We've been fortunate to include many first-hand stories from the recent 2022 IFYE alumni and other years as we talk with foundations, individuals, organizations, and businesses. Your help in giving us leads is also important and we would like to hear from more of you. As mentioned previously, you open the door; we'll walk through it and keep it open.

Development Subcommittee of Finance Committee

Under the umbrella of the Finance Committee, we recently formed a Development Subcommittee with the responsibility of helping staff identify and reach out to individuals inside and outside of our organization. The timing is perfect; as we celebrate our 75th Anniversary, we would love to get a total of 75 new businesses and contributors. YOU can help us with that! We still need two or three more alumni and other IFYE family members to join the subcommittee and help us strategize how to and where to identify new resources. Your efforts will help set the direction of the fundraising plan and staff then carry out the work.

Sitting in the chair of the IFYE Interim Executive Director, I see every day how important IFYE is to the world. As an IFYE alumna, last month I once again experienced the inexplicable knowledge that IFYEs do make a difference, we help each other in times of need, and we do our best to work toward Peace Through Understanding.

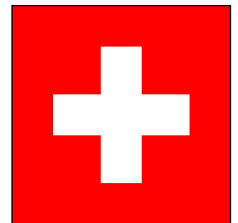

2023 Farm Bill Activities

Farm Bill activities continue and have gained intensity since our 2022 November IFYE NEWS. In December, our returning IFYEs gathered in Washington, D.C., where we held a second “Meet and Greet” for Ag Committee staffers. Thanks to Senator Joni Ernst’s office, we were able to hold the event in the Capitol Senate meeting rooms, which IFYE greatly appreciated.

After IFYE returnee debriefing, President Jan Wood, Interim Executive Director Carolyn Hansen, Board Secretary Barbara Batie and IFYE alum Bob Jenkins visited Agriculture Aides in U.S. Representatives’ and Senators’ offices including Senators Stabenow (MI), Boozman (AR), Brown (OH), Ernst (IA), Thune (SD), Durbin (IL), Grassley (IA) and Fischer (NE).

We were also able to visit with House of Representatives staff for Representatives Glenn Thompson (PA), Adams (NC), Costa (CA), Kaptur (OH), Price (NC), Miller-Meeks (IA), Shontell Brown (OH), Hayes (CT), Schrier (WA), LaTurner (KS), and McHenry (NC). Generally, our message was received positively.

Some aides in Republican Senate offices advised us that there was to be “no new money/programs” in the 2023 Farm Bill. Despite that message, the Farm Bill Committee continues to reach out to all members of the House and Senate Ag Committees. IFYE alumni have attended several Congressional Farm Bill Listening Sessions (*See the Listening Session article on page 10*).

Seeking Appropriations

In several of our sessions with Ag Committee staffers, we were advised to seek Appropriations. We had discussions with Rep. Kaptur’s staff regarding submissions for 2024 appropriations, which were due to the House Appropriations Committee on March 24. We were told that the committee has received multiple requests to fund IFYE. At this point, we do not know who submitted those requests.

“Marker Bill”

In the Senate, Senator Sherrod Brown (OH) agreed to sponsor a “marker bill” for the 2023 Farm Bill for IFYE. His Ag Legislative Aide has been very supportive since we first met with him last June. The bill is titled “International Agriculture Cultural Exchange Program” and while it does not name IFYE, it is written specifically to match the IFYE Association of the USA, Inc. This marker has been submitted to the Senate Committee on Agriculture.

Continued Communications

These are all very positive steps. There will need to be continued communication between IFYE and both the House and Senate Ag Committees as they start “making the sausage.” There are 27 new members on the House Ag Committee since mid-term elections. One of our major efforts over the next few weeks will be to reach out to all those Representatives and their staffers to provide them with documents that support our cause and to plead our case.

A Call to Action

Some IFYEs believe that we are definitely going to receive some federal government monies. This is not so. The Farm Bill Committee continues to promote IFYE; however, this is far from a certain thing.

Email Campaign

Now is the time for all IFYEs to support this effort by beginning an email campaign to reach:

- 1) the members of the House and Senate Ag Committees and
- 2) your own Representative and Senators.

We have tried to make the email campaign as easy as possible by providing a sample letter and tips for writing your Congressmen and Senators on the IFYE website.

- The link will open to a copy of the sample letter that you can download and then copy and paste into the email of your representative and/or senator.
 - Be sure to add a sentence or two regarding your own IFYE experience.
 - If you went on program from a different state than where you now reside, clarify that as well.
 - If you served as a host family or other IFYE family member, also mention that.
- Postal mail is subject to longer delays than email in reaching your Congressmen - who all have email today. So, it is best to email anything being sent regarding the 2023 Farm Bill or other urgent matters.

For information on how to contact your senator and/or representative, click on the sentence spotlighting the tips. If you happen to know a member of the House or Senate Ag Committee, by all means, direct an additional email to that person.

All letters are important as, each time we reach another Congressman or Senator, we spread the word about IFYE.

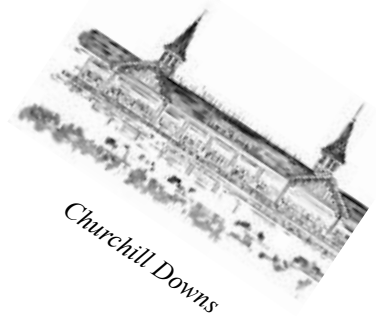

Farm Bill Listening Sessions

2023 Farm Bill Committee

Both the U.S. House of Representatives and the Senate Agricultural Committees have sponsored Congressional Listening Sessions over the past several months. We've reported on some of these Farm Bill Listening Sessions in the IFYE Updates and IFYEs in Touch.

Some of the Listening Sessions that IFYE Association members have attended are listed below. In addition, you may find other states' previous and upcoming Listening Sessions by searching on the Internet under "state farm bill listening sessions." There are many sessions occurring in the next few months and it would be appreciated to have as many sessions attended as we can by our program alumni and other supporters. April 20, 2022 – Michigan: The first session was sponsored by Senator Debbie Stabenow. Larry Gould attended but was not able to address the room. However, he was able to have a personal conversation with Senator Stabenow's Agriculture Legislative Aide. Upcoming Michigan Farm Bill Listening Sessions are scheduled for this July and August. January 13, 2023 – Farm Show in Harrisburg, Pennsylvania: President Jan Wood and IFYEs "AK" Kissel (and SPIFYE Helga), Dave Allgeier, Hope Bittner, and Janice Tekely-Yaple attended a Farm Bill Listening Session at the Pennsylvania Farm Show sponsored by Glenn "GT" Thompson. The group met in a private session with Chairman Thompson (PA) and a few members of the U.S. House Ag Committee. We had a productive discussion about IFYE's efforts to find funding and potential other approaches such as matching dollar-for-dollar funding.

January 18, 2023 – Fort Wayne, Indiana: IFYE alum and Board Member, Roger Sherer, attended. Roger was not able to address the room nor the panel but was able to speak with some panel members.

February 14, 2023 – Tulare World Ag Expo, California: Don Campbell was able to speak personally with Chairman

Thompson as well as California Ag Committee members Representatives Doug LaMalfa and John Duarte.
