

National 4-H Leadership Trust Convenes Task Force on 4-H International Programs IFYE ASSOCIATION BOARD OF DIRECTORS PRESENTS RESOLUTION

The Task Force on 4-H International Programs recently named by the National 4-H Leadership Trust is at work. It is chaired by Dr. Cathann A. Kress, Director, Youth Development, National 4-H Headquarters, USDA/CSREES, an indication of the importance that USDA, the Extension System and the National Trust have placed on the charge to the Task Force.

The National 4-H Leadership Trust provides a unified national voice for the stewardship of 4-H Youth Development. It meets regularly to sanction and consider direction for nationally coordinated 4-H programs.

The Task Force is to evaluate and make recommendations regarding the future of 4-H International programs. Its report to the National Trust is expected this fall. Decisions on the recom-

mendations and an approved plan for the future will then have to be finalized and set in motion.

The Eighth World IFYE Conference in Sigtuna, Sweden, celebrating the 55th anniversary of the IFYE program, is underway as we go to press. Nearly 500 IFYE alumni and friends - over 130 from the U.S. have gathered for the occasion. I welcome this opportunity to visit Sweden. When I applied for the IFYE program fifty years ago, my choice of countries were Sweden, Switzerland and Scotland, in that order. I was assigned to Turkey. In my years of travel and work in the international arena, I never got to Sweden. It has taken me fifty years! I don't in any way regret my assignment to Turkey, but it seems special to get to Sweden, be it all too short a visit, during my 50th Anniversary as an IFYE delegate.

During the week of the World IFYE Conference, our son, Dean, Jane and our three grand-redheads, will depart for Colombo, Sri Lanka, where he has been assigned as the economics officer with the U.S. Embassy. You may remember that their youngest daughter, Grace, was born a few ounces over one pound in Asuncion, Paraguay, at the time of the 7th World IFYE Conference in Washington, D.C., in 1998. We're looking forward to the holidays in Sri Lanka, that beautiful island country off the coast of India.

Three celebrations so far this year. My group of 116 U.S. IFYE delegates and the 142 inbound IFYE exchangees in 1953 are celebrating their 50th anniversary. My wife, Linda, and I celebrated our 40th wedding anniversary in July. And in May I celebrated my 70th birthday. Oh, how the decades sail by! Speaking of sailing, note that IFYEs in the early years traveled by ship (see page 1 and the English/ Welsh article on page 3), with orientation and language training a part of the several days of travel to their host countries.

Let me introduce you to our new publisher -Natalie Bosecker of Champaign, Illinois. As previously announced, nationally coordinated programs are currently on hold awaiting the decisions and direction of the Trust late this year or in early 2004. Enthusiasm for global education and exchanges and 4-H related youth program development in other countries is very evident amongst the members of the Task Force. It is probably fair to say that the future of these programs is bright, but the kinds of

1966 IFYE Shares Joys of Revisiting Host Country & Families

Martha Hikes Muratsuka Albin, PA-Switzerland 1966, a longtime resident of Hawaii and a lifetime member of the IFYE Association, revisited her host country last summer. A letter about her visit and related travels provides our guest editorial:

When I was an IFYE to Switzerland in 1966, I thought the trip was a "once in a lifetime" experience. Little did I know that I would have an opportunity to revisit my beloved country and again stay with some of my host families. Last summer, my dream came true. My husband, Bob, and I spent a month staying with my families in Switzerland and friends in England and Germany. One of my hosts was Klaus Huber, Switzerland-WY/NJ 1965. We also visited Judy Meggison Burgass, United Kingdom-PA/MT 1965.

It was very rewarding to find that I could still converse in "Schweizer Deutsch" (Swiss German) after 36 years, never having had formal study in German.

It was also exciting to visit Frommen and Durrwangen, Germany, from where my ancestors had traveled in 1650 to settle in America, and Bob's ancestral land on the Isle of Skye, Scotland.

We wish that more individuals would spread the words of peace through getting to know and accept each other as IFYEs have done for 55 years.

I have retired after 30 years of teaching and librarianship in the elementary schools of Hawaii. I now volunteer and work part time for the Family Peace Center. Bob is also retired and volunteers as a maintenance worker on the teak decks of the Battleship Missouri.

1953 English and Welsh Exchangees Celebrate 50th Anniversary

The 1953 English and Welsh exchangees to the U.S. and Canada gathered on April 12 - 13 for a reunion at The Belfry Hotel in Warwickshire, England, to celebrate the 50th Anniversary of their IFYE experience. Four of the nine were able to attend along with an FFA exchange participant they adopted as an honorary member of the IFYE delegation.

Joan Playle Hockley, England-Ohio/Missouri, organized the celebration. Others attending included Gladys Pritchard Joseph, Wales-Illinois/California; James Muir, England, FFA program; John Emyr Jones, Wales-Connecticut/ Colorado; and Robert McKenzie, England-South Carolina/Iowa.

Also responding to the invitation, but unable to attend, were Audrey Sellers Forbes, England-Maine/Indiana, and Elizabeth Bush Kennaird, England-Massachusetts/Kansas.

All of the participants are still in England and

Wales except for the Kennairds. Elizabeth and her husband emigrated to Rhodesia/Zimbabwe in 1958, where they and the family have experienced considerable hardship in recent years. They retired and were forced out of their home in January of this year. They had to leave the country, where they report that commercial agriculture has been almost totally destroyed, law and order is non-existent, and famine is at hand.

The other three English IFYE exchangees were not located: Robert Ellwood, Pennsylvania-Illinois; David Guthrie, Montana/Missouri; and David Williams, Wyoming-Kansas; as well as the second FFA program participant, John Pickthall.

The delegation traveled by sea to Quebec, Canada, aboard the R.M.S. Franconia, enroute to the U.S. They returned to England and Wales from New York via the R.M.S. Queen Mary.

Each exchangee was presented with memory booklets and biographical information on the

8th World IFYE Conference Underway

The 8th World IFYE Conference is underway in Sigtuna, Sweden. The conference began Saturday evening, July 19, as conferees gathered at St. Per Ruins in downtown Sigtuna, the ringing of church bells, and a Torch Light procession to St. Mary's Church for a vesper service.

The official opening of the conference was Sunday morning in the Sigtuna Town Square.

Over 460 IFYE alumni and friends are attending, including over 100 each from Sweden and the U.S.

The conference ended Friday evening, July 26, with a farewell party and a "taste of the Swedish kitchen."

Missouri's State Fair Global Village

The Missouri IFYE Association was awarded one of the IFYE Association of the USA's 2002 Mini-Grant awards. The \$200 award assisted with a "Global Village" activity at the Missouri State Fair.

Each child was given a "4-H Passport to the World" complete with a polaroid photo of them dressed in a costume from another country. The passport included instructions for games of other countries and included information about 4-H-like programs around the world. Visitors could try on costumes, play international games, and do crafts of other countries.

South Dakota Welcomes Proposals For 2002 Conference Project Grants for the Eradication of Diabetes Within Native American Tribes.

The South Dakota Conference service project raised \$6,000 to support programs that will aid a major problem within Native American tribes: the eradication of diabetes. Two grants have been awarded.

Additional grants are available. The project committee encourages proposals that are available for projects anywhere in the U.S. Alumni are encouraged to contact Native Americans and individuals working with possible programs to advise them of this opportunity.

Proposals for this second round funding must be postmarked no later than September 3, 2003. Grants have been made to Marcella Gilbert of Brookings, SD, a student at South Dakota State University, and Susan Ricci with the Indigenous Diabetes Education Alliance (IDEA), a non-profit organization educating diabetic Native Americans about nutritional lifestyle changes, in Spearfish, SD.

Gilbert is working with the Sisseton-Wahpeton community of the Sioux Tribe. She is providing four two-day workshops on the importance of exercise and good nutrition, which lessen the negative effects of diabetes.

Ricci is project director of IDEA. Project funds will support a newsletter with healthy bison recipes and preparation tips, nutritional information for the diabetic, and references to other resources, for the study participants and the Lower Brule community.

Traditional Native American diets consisted of wild roots and berries (rather than today's processed foods higher in sodium and sugar) and in boiled, dried, or roasted wild game (rather than government rationed beef - higher in fat and cholesterol). Adding to the problem are commodity foods and the popularity of fast foods amongst Native Americans.

International Voluntary Services (IVS), a private, nonprofit organization founded in 1953 to provide volunteers for two years to work in developing countries, discontinued operations last fall. "We closed down due to lack of funding as we planned our 50th Anniversary IVS Reunion. All good things must come to an end and we take pride in what we did when we did it," reports IFYE alum Verle

International Voluntary Services Lanier, MT-Japan 58, and IVS volunteer.

IFYE Foundation Report

The IFYE Foundation held its annual meeting June 30, 2003.

Highlights since July 1, 2002, included grants to the IFYE Association in the amount of \$11,500 to close out the 2002 IFYE program and up to \$18,500 in support of the 2003 program. Foundation assets after these grants total just over \$40,000 as of June 30, 2003. The board noted with great appreciation the \$28,506 of support from over 230 contributors, which help make the ongoing IFYE program possible.

Two new directors were elected to the Board of Directors. They are **Doug Putnam** (CT - Region A) and **Wesley Tschetter** (SD -Region C). Putnam is treasurer of the Connecticut IFYE Association and was recipient of the IFYE Association's Friend of 4-H International award in 2001. Wesley Tschetter, SD-Israel 1969, replaces Don Campbell, CA-Spain 1969, who retired after more than five years of service on the board.

Charles Larson, CT-Denmark 1948, accepted an invitation to be an Advisor to the board.

The Board considered potential use of \$6,066 received from the 2002 National 4-H Congress Centennial Dimes project. It was agreed to provide these funds to the IFYE Association with the recommendation that they be used to encourage IFYE alumni participation in the Congress to convey the IFYE story in hopes of stimulating more applicants in the future.

On behalf of the 4-H International Programs Committee (IPC), the Foundation signed an agreement with the U.S. Department of State to support a 4-H component of the FLEX program, which brings 40 Eurasian students to live with families and attend local high schools.

Board members heard a report from Mel Thompson on the National 4-H Leadership Trust's Task Force on 4-H International Programs looking into the future of 4-H International education and exchange programs and adopted a positive response in their support.

Current officers were reelected: Stanley Dreyer, president; Mildred C. Weidemann, vice president; Dick Tenney, secretary and Eldon R "Bud" Aupperle, treasurer.

IFYE Foundation Contributions
