#### **Financial Picture**

In 2013, revitalization of IFYE as a nationally-directed independent organization began. Funding proved difficult but IFYE made great strides increasing both Outbound and Inbound participation. Thanks to the 2018-2020 Organizational Capacity Campaign (OCC), donations from a small group of generous alumni strengthened IFYE's treasury. But COVID shut down IFYE in 2020 & 2021 as costs continued. Now, IFYE and so many other organizations face the long-term effects of the COVID years plus current growing economic challenges. As previously stated in letters and email to all IFYE Alumni, we will not be operating an IFYE outbound and inbound program in 2024.

The OCC monies were expected to support the program for three years. We have stretched the OCC and a significant bequest to nearly six years. In several months IFYE may face initiation of its long-in-place Continuance Plan.

The Executive & Finance Committees want you to know these financials from the last six years:

January 2017 to October 2023	
Total Revenues: (including alumni donations, OCC moneys, bequests corporate donations, grants, and commodity sponsor support)	\$1,782,000
Total Expenses:	\$1,674,000
October 2023 Balance in Raymond James Acct.	\$ 142,000

Total expenses for all years (including 2020 & 2021 w/COVID) cover: administration, programs, operations, oversight, and other required costs such as Board insurance, Inbound and Outbound insurances, registrations to solicit funds in most states, bookkeeping & accounting, website maintenance, mailings & postage, etc. Also, airfare/travel costs have skyrocketed for 2022 and 2023.

Efforts stretching your dollars are multiple such as securing maximum (three months) Payroll Protection Plan (PPP) reimbursement during COVID in 2020 & 2021. After maintaining two full-salaried staff for those two years, the Executive Director's position became part-time with an Interim Executive Director. Everyone has worked to spend very judiciously.

Our CPA-audited records and IRS 990 form statements are available for review on request.

Your Board and Staff have strived to be good stewards of IFYE funds. We appreciate your past donations and ask for your continued moral and financial support as we work through 2024 – a year of internal restructuring. The goal, of course, is to develop an operating and financial plan allowing IFYE to resume a full program in 2025.

Again, thank you for your interest and support.

## IFYE 75<sup>th</sup> Campaign



Reminder of ways to give to IFYE USA:

At age 70 ½ and older, you can give directly from an IRA to IFYE USA through a Qualified Charitable Deduction (QCD). Typically, this is handled through a signed form request to your bank or investment firm where you specify how much you want to withdraw as your donation to IFYE USA, and then the funds are sent by check directly from the bank/firm to IFYE USA. No income taxes need to be paid on this method of withdrawal directly from your IRA, however, you do not also get to itemize this IRA withdrawal on your income tax return as a charitable deduction. Speak with a tax adviser/preparer to see how your donations should be handled on your Federal income tax return.



Funds Raised

- Use some of your required minimum distributions (RMD) from IRA funds before the end of the year to make a significant donation to IFYE USA.
