National 4-H Leadership Trust Report...on 4-H International Programs Association Survey A Salute -

Happy Birthday Kathleen!

I was riding high as the new year got underway...in more ways than one. We were having a great time with our family in Sri Lanka and I had hopes that 4-H International exchange programs were going to regain the stature and support of earlier years.

Long awaited...the report of the National 4-H Leadership Trust on 4-H International programs and related 4-H citizenship activities arrived just as we were going to press - see article on page 3.

Disappointed? I have to admit I am. It does speak to several program issues that I anticipated and support - clientele areas of emphasis and more emphasis on those of 4-H age, safety and security, increased state responsibilities, programs with counterpart 4-H programs in cooperating countries, Extension oversight and accountability, and an increased tie-in to the overall 4-H citizenship emphasis. It does not provide for national staffing or coordination of international exchanges and relationships.

I had hoped that National 4-H Council would have been directed to reinstate their long time management of 4-H International

programs and renew an area of programming that was one of the reasons it was founded...or, that a staff position at National 4-H Headquarters would have been created to fulfill that role. Neither happened. We need this exposure for coordination in the U.S. and for vital relationships with countries around the world.

Perhaps the programs that most of us have known have served their time. Interest has dwindled over the years. In 2004 we have twelve U.S. participants on the IFYE Representative program - seven for 6 months, two for 3 months, and three for 4-6 weeks. A long way from the 1950-70s when we had as high as 160 U.S. participants on six month programs each year.

One person queried responded, "the 4-H movement is not clear about what it wants to do with international. In fact I would say 4-H is quite ambiguous."

Continued emphasis on state-based programs gives emphasis to the fact that 4-H is a grass-roots organization. Programs need our support at the local and state levels. Make your feelings known to your Extension staff and support your state program with financial and/or volunteer assistance. We need to accept that programs are going to be different in the future!

The Association needs your input - into what it is, it's mission, it's name, how it can better serve alumni, conferences, this publication, what your exchange experience meant to you, influence on your education, career, retirement, life. Is it still relevant? Should it be broadened in name and scope to

include all 4-H International exchange alumni and others interested. Please complete the survey insert and return it by July 15. A summary of the returns will be shared in the next issue.

I'm still reflecting on our time in Sri Lanka. Didn't think it possible, but they put our entire family on an elephant, "Rahja," for a safari ride through the jungle. It reminds me of a new income-generating endeavor - fascinating, and unbelievable to some. They are now processing elephant dung to make gift wrap, stationary, picture frames and other products. Almost everyone I share the gift wrap with, drops it as they read the label...and smell their hands! A unique project to raise the standard of living of some others!

National 4-H Leadership Trust Establishes Guide for 4-H World Citizenship Programs

4-H World Citizenship is the new name of the 4-H program component involving all citizenship and international programs, including exchanges. This is the National 4-H Leadership Trust's decision following recommendations of State 4-H Leaders and the Task Force on 4-H International Education.

The Trust dictates that any activity undertaken by the 4-H movement in the area of 4-H World Citizenship will:

- Provide the safest program possible within our control.
- Recognize the uniqueness of each state and be designed to meet the needs of each state.
- Acknowledge that the exchange opportunities may or may not be an Extension sponsored activity.
- Have a state 4-H staff member who is responsible for the use of the 4-H Name and Emblem within the state.
- Expect all multi-state world citizenship

programs to be sanctioned by some entity within the Extension System that accepts accountability and be sanctioned and authorized by National 4-H Headquarters.

- Embody the essential elements of 4-H.

Further, the Trust fully endorses the 4-H Task Force recommendation to "explore options of how to manage all multi-state, 4-H age, international exchange programs and, through fee generation, have the ability to support management expenses, including staffing. Exchanges should be a part of a sequential learning experience, not a stand alone experience. Risk management and program quality will be on the forefront of concern."

Several issues remain to be clarified. Who will provide the practical direction related to implementation? There are the guidelines of the Council on Standards for International Educational Travel (CSIET) that need to be followed in the interest of relationships with

Immigration, the U.S. Department of Agriculture, and the U.S. Department of State. The issue of exchange visitor visas is a major concern - visas are becoming more of a challenge each year for both visitors to the U.S. and for U.S. participants. And relationships with countries need coordination to eliminate multiple contacts and confusion.

Jim Rutledge, Oregon's State 4-H Leader and a member of the Task Force, visited with the IFYE Association board of directors recently. He pointed out that the feeling within the Task Force, amongst State 4-H Leaders, and Extension overall, is that 4-H World Citizenship exchange programs should be for 4-H age young people, volunteer 4-H leaders, individuals studying for careers in Extension and 4-H, and Extension staff, and that emphasis should be on 4-H youth connections, staff and volunteer training, and on assistance to countries with 4-H type programs. This appears to be on target with the report of the National 4-H Leadership Trust.★

In commemoration of the 30th anniversary of her IFYE experience, Anita Hakkila Smiley, CT-Finland 1956, organized a group tour to her host country in 1986. That was only the beginning. In July of this year she will make her 10th excursion with a group of 33 from throughout the U.S. - introducing them to the "wonders of my beautiful host country and its welcoming people."

Some of the groups have visited the Finnish 4-H Program. In 2001, her eighth tour group was welcomed by Finnish 4-H the day they arrived in the country. During that visit Anita presented a wall quilt to Seppo Hassinen, director of Suomen 4H-Litto (Finnish 4-H), for their office. The quilt had been made by members of a 4-H Club in Ledyard, Connecticut, led by her friend, Janet Barnet. Photos on the quilt depict their 4-H projects.

While in Finland last fall, Anita, and one of her host sisters in 1956, Raija Ylieskola, visited Kirsti Hirvensalo, the Finnish 4-H exchange coordinator for many years, including the year Anita was an IFYE. "I visit Kirsti whenever I have a chance," says Anita, "I have always been inspired by her energetic spirit. It is largely due to her meticulous coordination of our IFYE experience that I was inspired to organize group tours to Finland." Kirsti now resides in a retirement home in Helsinki.

Anita and her husband, Jack, have an even more direct connection to the country now. Their son, Greg, is married to a Finn he met when traveling with Anita in 1993 to learn about his grandparents' country. Anita wrote, "A casual outing on a Saturday evening 'to see what the young people are doing in the city changed his life forever.'" Greg and his wife, Soile, and their two children live in Masku, Finland. And two grandchildren increase the desire for Grandma Anita and Grandpa Jack

4-H International Alumna and Extension Staffer Helps Organize Rural Youth Program in Namibia

Two U.S. 4-H International exchange alumni and an Extension agent from Maine helped develop one of two new youth programs in Namibia, Southern Africa. Rural Youth Clubs of Namibia (RYCN), a program for 15- to 30-year-olds, was piloted by the Food and Agriculture Organization (FAO) of the U.N. and Namibia's Ministry of Higher Education.

Sue Benedetti, WY IFYE to India 1966, served as Youth Development Specialist and lead consultant in developing the program. While on sabbatical from the University of Minnesota, Jane Plihal, MN YDP to Botswana 1970, developed a Food & Nutrition Leaders Handbook, and Frank

Wertheim, Horticulture Extension Agent and former Peace Corps Volunteer developed a Vegetable Garden Leader's Handbook. A Ugandan consultant prepared small business development modules for youth in rural areas.

Shortly before and unknown to the organizers, a similar program for 6- to 15-year-olds began through cooperative efforts between Finnish 4-H and a local organization. This program operates in three regions reaching over 1000 members in 96 clubs.

Activities in the development of RYCN included participatory planning at local and regional

levels; needs assessment and curriculum development, volunteer leader training; and individual and group income-generating projects and activities.

Starting a club for young people who have never participated in a meeting presented a major challenge. Even the leaders have not participated in meetings (other than in very informal settings). Training has helped volunteer leaders gain skills to organize clubs, conduct meetings and teach their members to do the same.



Namibia Rural Youth

Benedetti worked with a Regional Youth Officer to design a training program on leadership, organization and management. They tested it with 30 volunteer leaders, ages 20 to 32. The new

volunteers organized nine clubs with more than 300 members within two months.

Plihal developed a learning-based handbook to help volunteer leaders create food and nutrition projects, and train rural youth in basic nutrition and its practical application. With only two trained nutritionists in the country, this approach is imperative.

Wertheim, in charge of Maine's Master Gardener Program, used many of that program's concepts to write and test lessons in low water usage vegetable gardening for this very arid country.

IFYE Foundation Update

Individual contributions continue to come in at a record pace. In the program cycle this year (August, 2003 to present) \$31,785 has been received to date. This generous support is greatly appreciated, according to Stanley Dreyer, President of the IFYE Foundation. This not only provides a basic support level for the current 2004 program, but provides a financial base for future developments.

The Foundation is making available up to \$15,000 for the 2004 IFYE Representative program - an amount similar to what was needed for the 2003 program. Special support is being provided to states where they have a formal reporting program and individuals are required to devote time to this responsibility. In addition, support is being provided for participant insurance, assistance with inbound participants not part of a two-way exchange, and help in equalizing travel costs.

The Foundation has again been asked by the 4-H International Program Committee (IPC) to be the applicant to the U.S. Department of State for special funding of the 2004-05 Future Leaders Exchange (Flex) program. This provides funding for 40 high school students from Eurasia to

live with families for a year and attend high school in the U.S.

During the past six months the President of the Foundation served on an exchange committee of the Task Force on 4-H International Programs. This committee helped develop a proposal on international exchanges as part of an overall 4-H World Citizenship program for consideration by the National 4-H Leadership Trust. Mary Kay Munson and Mel Thompson, both IFYE Association board members, served on the committee, as well as the Task Force.

Communicating the 4-H Culture

In April, the annual development conference of State 4-H Foundations focused on the successes in funding 4-H programs and enhancing the competitive position of 4-H among young people relative to other youth organizations and activities. The National 4-H Council reported on extensive consultations with 4-H members to better describe the value and impact of 4-H on youth. What has evolved is imbedded in the following statement: "4-H is a community of young people across America who are learning leadership, citizenship and life skills." There

4-H Hall of Fame

Several 4-H International alumni and others who have played a key role with 4-H International Programs over the years have been honored as Laureates in the National 4-H Hall of Fame.

Alumni honored in the 2002 Centennial Inaugural class included Maurice E. Johnson, ID-Sweden 1954; Paul Hoshiko, CO-Scotland 1952, Urania Belle Linn, PA-Luxembourg 1955, and Russell G. Mawby, MI-United Kingdom 1948. Others included Beatrice Cleveland, former Ohio State 4-H International Programs Leader, Kathleen S. Flom, former 4-H International staff of National 4-H Council, and the late Dr. Edward W. Aiton, the coordinating force when establishing the IFYE program.

Honored in 2003 were former state 4-H leaders Richard R. Angus, MN-Italy 1956, and Eugene Williams, OK-Travel Seminar to Denmark/Norway 1984.

Those honored recently in the 2004 induction ceremony at the National 4-H Youth Conference Center in Chevy Chase, Maryland, included Delores L. Andol, MN-Travel Seminar to Botswana/Kenya/Swaziland 1976; former state 4-H Leaders Frank Graham, Missouri; James F. Sargent, Montana; Cecil Staver, Colorado; and Arne G. Kettunen, Michigan, who also worked with Ed Aiton in establishing the IFYE program, accompanied the 1952 delegation to Europe, and assisted with the development of 4-H in Finland; James Marquand, former State 4-H International Program Leader, Ohio; and Eleanor L. Wilson, whose responsibilities on the national 4-H staff at USDA included citizenship and international programs.
